The Fifth General Assembly of the Islamic Organization for Food Security (IOFS) held in Tunis, the Republic of Tunisia, on 10-11 October 2022/14-15 Rabi Al-Awwal, 1444H

<u>Referring</u> to relevant provisions of the IOFS Statute on drawing up the general policy of the Organization, particularly the one on the creation of Food Security Reserves,

<u>Recalling</u> Resolutions adopted by the 4<sup>th</sup> General Assembly of IOFS held online in Nur-Sultan, the Republic of Kazakhstan, on 08-09 September 2021,

<u>Cognizant</u> of the mandate by the 8<sup>th</sup> OIC Ministerial Conference on Food Security and Agricultural Development, held on 24-25 October 2021 in Istanbul, Republic of Turkiye, for the IOFS to implement all necessary steps towards OIC Food Security Reserve System,

<u>Underscoring and highly appreciating</u> the important work and efforts the IOFS Secretariat has been undertaking in this regard,

- 1. **Approves** the text of the Memorandum of Understanding on the creation of OIC Food Security Reserves (MOU), as a model template;
- 2. **Invites** the governments of 11 (eleven) sub-regional Member States (Afghanistan, Albania, Azerbaijan, Iran, Kazakhstan, Kyrgyz Republic, Pakistan, Tajikistan, Türkiye, Turkmenistan, Uzbekistan) to consider the formation of a Pilot Regional Food Security Reserve through the signing of a MoU and the formation of a Steering Committee on the basis of which rules governing/regulating the Regional FSR and other necessary decisions would be approved;
- 3. **Requests** the relevant OIC Institutions to provide their economic and financial support, if Member States decide that a feasibility study for Regional FSR is necessary;
- 4. **Emphasizes** the report of the OIC Expert meeting held in Astana, Kazakhstan, on 27-28 September 2022, which states readiness to create the regional Food Security Reserves;
- 5. **Calls** on the Member States to continue coordinating among themselves the establishment of necessary food reserves on national and regional levels in order to minimize the risk of food shortage and increase their food storage capacity;
- 6. **Requests** the IOFS Secretariat to take all necessary steps to ensure that the aims and objectives for the establishment of Pilot Regional FSR are realized, and to report at the next session of the General Assembly.

#### RESOLUTION № 10FS/2022/5GA-9 ON ESTABLISHMENT OF "10FS FUND"

The Fifth General Assembly of the Islamic Organization for Food Security (IOFS) held in Tunis, the Republic of Tunisia, on 10-11 October 2022/14-15 Rabi Al-Awwal, 1444H

<u>Referring</u> to the Resolution No IOFS/GA/1-13-2019 of the  $2^{nd}$  General Assembly and relevant provisions of the IOFS Statute on drawing up the general policy of the Organization, particularly the one related with establishing Institutions to be a subsidiary of IOFS.

Recalling the *IOFS VISION 2031 for Enabling a Sustainable OIC Food System*, adopted by the Fourth General Assembly of the Islamic Organization for Food Security (IOFS) held online in Nur-Sultan, the Republic of Kazakhstan, on 08-09 September 2021/01-02 Safar, 1443H,

<u>Taking into account</u> the need to increase intra-OIC economic cooperation particularly in the field of agricultural development and food security with emphasis on joint funding and structuring food supply chains among OIC Member States,

- 1. **Expresses appreciation** to the Secretariat of IOFS and the international consultants' consortium for completing detailed feasibility study;
- 2. **Adopts** the "Grain Fund" feasibility study prepared by a consortium of international consultants and in accordance with the operating nature indicated therein renames it as the "IOFS Fund":
- 3. **Requests** the IOFS Secretariat to elaborate on location of the newly established "IOFS Fund" and provision of all necessary institutional and logistical arrangements for its proper operationalization;
- 4. **Underscores** that the "IOFS Fund" may be an important tool for Member States to avoid different factors that destabilize the grain/food market price policy, while reducing vulnerability and dependency on volatile global food prices and agriculture by increasing OIC agri-food production system and building up intra-OIC food supply chains;
- 5. **Stresses** that the "IOFS Fund" may strengthen partnerships with national and Islamic financial institutions of Member States towards "IOFS Vision 2031" and effective implementation of the strategic programmes framework;
- 6. **Encourages** the Member States, the Islamic Development Bank Group and other relevant OIC Institutions to identify key areas of cooperation and provide necessary technical assistance and financial support to the new IOFS Fund;
- 7. **Requests** the IOFS Director General to follow-up the implementation of the present Resolution and report to the next session of the General Assembly.

#### RESOLUTION № 10FS/2022/5GA-8 ON

### ESTABLISHMENT OF SHEEP FARMING FUND AS PART OF IOFS LIVESTOCK ECOSYSTEM

The Fifth General Assembly of the Islamic Organization for Food Security (IOFS) held in Tunis, the Republic of Tunisia, on 10-11 October 2022/14-15 Rabi Al-Awwal, 1444H

<u>Referring</u> to relevant provisions of the IOFS Statute on drawing up the general policy of the Organization, particularly the one related with establishing Institutions to be subsidiary to IOFS,

Recalling the *IOFS VISION 2031 for Enabling a Sustainable OIC Food System*, adopted by the Fourth General Assembly of the Islamic Organization for Food Security (IOFS) held online in Nur-Sultan, the Republic of Kazakhstan, on 08-09 September 2021/01-02 Safar, 1443H,

<u>Taking into account</u> that the global demand for animal products would grow further in the next decades due to expanding human populations and the average increase of meat consumption per person, consequently, livestock may play a critical role in alleviating hunger and malnutrition in OIC Member States,

<u>Bearing in mind</u> that livestock production in the OIC geography is an important subsector of the agricultural industry and makes a significant contribution to the national economies of Member States,

- 1. **Agrees** with the establishment of the Sheep Farming Fund (SFF) within the framework of the Livestock Ecosystem as developed by the IOFS in cooperation with the Government of the Republic of Kazakhstan, and **encourages** the Member States to assist the Organization throughout the whole establishment process and functioning of such export-oriented structures;
- 2. **Welcomes** IOFS assistance to Member States in the sustainable development of livestock sector by expanding its conceptual vision "From gene to fork" modality, promotion of constant cooperation of Member States on various fields of livestock development through Centers of Excellence at regional level, facilitation of the exchange of knowledge and experience among research institutes, encouraging joint research activities and programs, supporting livestock farming through the use of advanced digital and information technologies and increase of its export capacity;
- 3. **Lauds** SFF for being a platform that may enhance domestic livestock sector for economic development, food security and poverty reduction (with focus on rural areas), growth of intra-OIC livestock production and market through increase of mutual trade and investments, while providing special support to smallholder farmers and livelihoods through sustained IOFS livestock ecosystem;

- 4. **Emphasizes** the importance of increasing of Halal market and cooperation among OIC Member States, which may also be achieved through SFF food safety and assurance mechanisms, and long-term off-take contracts between Member States that are livestock-producing and those that are livestock-consuming, while contributing for price stability of Halal meat in the OIC geography;
- 5. **Decides** that as per all arrangements started in 2022, the pilot project is to be launched in the IOFS Hosting country with further replication to other livestock rich OIC Member States, especially in Africa;
- 6. **Encourages** the Islamic Development Bank (IsDB) and other OIC Islamic financial institutions to identify key areas of cooperation and provide necessary financial support through the SFF;
- 7. **Requests** the IOFS Director General to follow-up the implementation of the present Resolution and report to the next session of the General Assembly.

#### RESOLUTION № 10FS/2022/5GA-9 ON

### SUPPORT TO AFGHANISTAN FOOD SECURITY PROGRAM AND YEAR OF AFRICA COMPLEX PROGRAMMES

The Fifth General Assembly of the Islamic Organization for Food Security (IOFS) held in Tunis, the Republic of Tunisia, on 10-11 October 2022/14-15 Rabi Al-Awwal, 1444H

<u>Pursuant</u> to the 2<sup>nd</sup> Statutory Goal of the IOFS and referring to relevant provisions of the IOFS Statute on drawing up the general policy of the Organization, particularly the one related with determining and making necessary emergency and humanitarian assistance,

Referring also to the mandate by the 17<sup>th</sup> Extraordinary Session of the OIC Council of Foreign Ministers on the Situation in Afghanistan, held on 19 December 2021 in Islamabad, Islamic Republic of Pakistan, for the IOFS to implement the Afghanistan Food Security Programs (AFSP),

<u>Recalling</u> the Resolutions adopted by the 4<sup>th</sup> General Assembly of the Islamic Organization for Food Security (IOFS) held online in Nur-Sultan, the Republic of Kazakhstan, on 08-09 September 2021,

<u>Taking into account</u> the deliberations of the 5<sup>th</sup> Meeting of Steering Committee for OIC STI Agenda 2026, held on 24 March 2022 in Islamabad, Islamic Republic of Pakistan, on, inter alia, developing an OIC Plan of Action for Africa, which, coincidently is in line with celebrations of 2022 as "IOFS Year of Africa",

Being appreciative of Member States, the IsDB and other relevant OIC Institutions for supporting the ongoing activities of IOFS,

- 1. **Appreciates** the importance of the *IOFS Official Humanitarian Visit to Afghanistan* on 16-19 April 2022 led by the IOFS Director General as a mean to implement the AFSP, particularly for handing over to the Afghan Minister in-charge of Agriculture, Irrigation and Livestock, six (06) "Water Cleaning Devices" to be installed in a similar number of most water scarce villages in Afghanistan;
- 2. Expresses high appreciation and gratitude for the generous contributions of the Republic of Kazakhstan in the amount of 100 000 USD and the Republic of Tajikistan in the amount of 10 000 USD to the humanitarian aid for Afghanistan people within immediate response projects under AFSP programme;
- 3. **Invites** Member States to positively respond to various requests by the IOFS Secretariat for providing their generous donations and support for successful AFSP implementation, especially under Immediate Response Stage;
- 4. **Encourages** the IsDB to include IOFS as one of the beneficiaries of the *Afghanistan Humanitarian Trust Fund* to serve as a vehicle to timely channel humanitarian food assistance to Afghanistan;

- 5. **Applauds** the decision of the 8<sup>th</sup> Executive Board Meeting of IOFS to name 2022 as the "IOFS Year of Africa", and **invites** all Member States and relevant OIC Institutions to actively participate and financially contribute for the successful holding of all related programmes and projects that are to be held in Sub-Saharan African Member States;
- 6. **Welcomes** kicking of the celebration of "2022 IOFS Year of Africa" with the holding of a *Capacity Building for Farmers on Water Management in Agriculture* and a *Workshop on the Development of Databases on Agricultural Statistics*, held as back-to-back events on 16-19 May 2022 in Niamey, Republique of Niger, in partnership with the Permanent Interstate Committee for Drought Control in the Sahel (CILSS) and Women Development Organization (WDO), and **encourages** the remaining Member States to also host relevant events as part of "2022 IOFS Year of Africa";
- 7. **Calls** for the active support of IOFS by OIC Member States, international donors, the UN Funds and Programmes and other international actors to generously contribute for the successful AFSP implementation as per the clause of 17<sup>th</sup> Extraordinary Session of the OIC Council of Foreign Ministers 19 December 2021, Islamabad;
- 8. **Requests** the IOFS Director General to follow-up the implementation of the present Resolution and report to the next session of the General Assembly.

<u>Recalling</u> the Resolution № IOFS/GA/1-14-2019 of the 2<sup>nd</sup> IOFS General Assembly and Resolution № IOFS/GA/3-7-2020 of the 3<sup>rd</sup> IOFS General Assembly,

<u>Acknowledging</u> the importance of engaging with private sector on issues and challenges relevant to food security, upon the institutional B2B mechanisms;

Having considered the report of the Director General on this issue,

- 1. **Decides** to relocate IFPA from AIFC, Astana, the Republic of Kazakhstan and establish it as a subsidiary of IOFS by virtue of Article 2 para 2 of its Statute within the jurisdiction of the United Arab Emirates under common law system;
- 2. **Expresses high appreciation and gratitude** to the general support provided by the government of the United Arab Emirates for the hosting of IFPA;
- 3. **Encourages** Member States to actively participate in providing valuable inputs to establish a mechanism for mutual cooperation with IFPA, and **invites** their national Chambers of Commerce or Food Unions to consider joining IFPA as honorary members towards facilitating leading private food sector companies to become its corporate members;
- 4. **Requests** the IOFS Director General, as the IFPA Chairman, to follow-up the implementation of the present Resolution and report to the next session of the General Assembly.
