IOFS AS A SUBJECT OF INTERNATIONAL LAW

Article 5 para 1

Every member state of the OIC may become a member of the Organisation upon signing the Statute, [...].

Article 21 para 1

THE STATUTE SHALL BE OPEN FOR SIGNATURE OF OIC MEMBER STATES FOLLOWING ITS ADOPTION BY THE ISLAMIC SUMMIT CONFERENCE OR CFM. IT SHALL BE APPLIED PROVISIONALLY UPON SIGNING BY AT LEAST TEN (10) OIC MEMBER STATES THROUGH THEIR ACCREDITED REPRESENTATIVES, AND DEFINITELY ENTER INTO FORCE UPON THE 30TH DAY FROM THE DATE OF SUBMISSION OF THE 10TH INSTRUMENT OF RATIFICATION OR ACCEPTANCE.

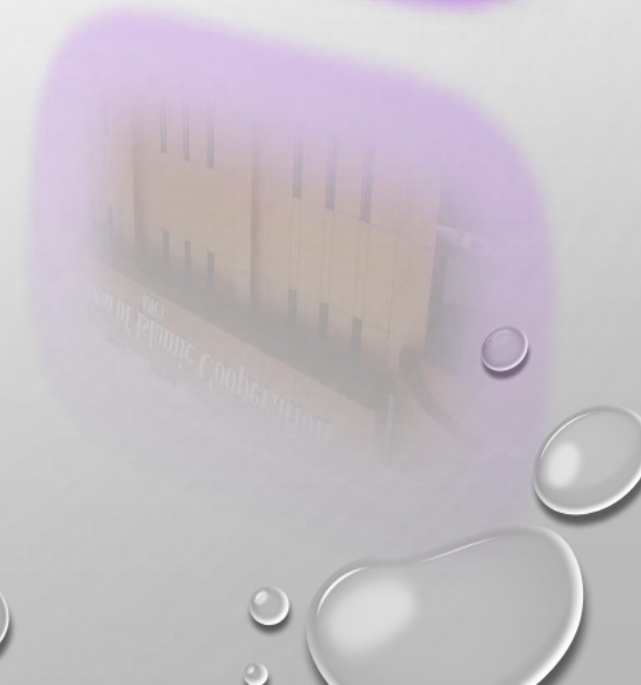
